We are a private, nonprofit organization that serves 4,000 patients each year. As the state-designated Community Mental Health Center (CMHC) serving Belknap and Southern Grafton Counties, we serve residents of the 24 towns of: Alexandria, Alton, Ashland, Barnstead, Belmont, Bridgewater, Bristol, Campton, Center Harbor, Ellsworth, Gilford, Gilmanton, Hebron, Holderness, Laconia, Meredith, New Hampton, Plymouth, Rumney, Sanbornton, Thornton, Tilton, and Wentworth.

We work in partnership with other healthcare providers, area hospitals, law enforcement, corrections, courts, school districts, and public health officials, and other community agencies to provide a continuum of care for our patients and improve the quality of life in the Lakes Region.

LRMHC accepts mode major medical insurances, Medicaid and Medicare, and offers a sliding scale for patients who meet financial guidelines. We offer help with completing application forms. Co-pays are expected at the time of service.

# **Housing Programs**

#### HOUSING BRIDGE SUBSIDY

A state-funded housing subsidy program through the Department of Health & Human Services. LRMHC manages the Bridge Program for the Belknap and lower Grafton counties and provides housing services for individuals who meet the criteria of the program to obtain and maintain independent housing in the community.

#### 811 PROGRAM

This program promotes integrated permanent supportive housing units. This "housing first" model does not require applicants to be connected with treatment at a mental health center, but clients do need to meet certain eligibility requirements to be deemed eligible; including being a low income person, aged 18-61 and diagnosed with severe mental illness.





## INTEGRATIVE HOUSING VOUCHER

A state-funded housing voucher program through the Department of Health and Human Services. LRMHC manages the Integrative Program statewide and provides housing specialist services for individuals who have criminal histories that would otherwise disqualify their ability to obtain housing services through traditional housing programs.

Important Note: This is a statewide program throughout New Hampshire.

If you are not eligible for Housing Choice Voucher, this program will provide subsidy until your eligibility changes. Once you become eligible to transition to the Housing Choice Voucher program, your assigned Housing Specialist will assist.

To qualify and remain eligible, you must be enrolled and maintain services with a mental health facility.

#### SUPPORTIVE SERVICES:

Throughout your transition, you will be connected with a liaison who will help provide supportive services, including but not limited to:

- · Finding and maintaining housing
- ADL (Activities of Daily Living) task reminders and support
- Case Management
- Medication Management & Prescriber Services
- Peer Support Services
- · Independent Living Skill Groups
